- 4- Navigate to **Boundaries/Protrusion** tab, add 2 records, delete one of them, Observe the update and delete actions
- Note: repeated on :Forbidden Conditions tab, Parking Conditions tab, Other Conditions
- 5- Open the attachments dialoge; Observe the Type description field
